# 4. First-Aid Measures

## 6. Accidental Release Measures

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: Contain spilled liquid with sand or earth. DO NOT use combustible materials such as sawdust. Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools. Dispose of according to local, state (provincial) and federal regulations. Do not incinerate closed containers. Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Ventilate area, isolate spilled material, and remove with inert absorbent. # 7. Handling and Storage

# 10. Stability and Reactivity
